WHEREAS Probation staff is responsible for supervising adult and juvenile offenders in Monterey County, and for the care and custody of juvenile offenders in Juvenile Hall and at the Youth Center;

WHEREAS Probation professionals uphold the law with dignity and recognize the public's right to be safeguarded from criminal activity;

WHEREAS Probation strives to employ the least restrictive means to obtain the desired behaviors, and utilizes a continuum of graduated sanctions so that intervention is appropriate for the severity of crime and effective in reducing recidivism;

WHEREAS Probation applies prevention and diversion strategies to deter youth from entering into the criminal justice system, and to facilitate access to services and programs which provide healthy alternatives for growth;

WHEREAS Probation staff works in partnership with law enforcement agencies, community-based organizations and groups to provide public safety services to the community, rehabilitative programs to offenders and restitution to victims of crimes;

WHEREAS Probation endorses prevention, intervention, advocacy and offender accountability, advocates community and restorative justice, and performs critical duties that support and protect victims of crime; and

WHEREAS Probation is a key player in California's Public Safety Realignment, which creates a historical change transferring authority on certain adult offenders to the local level, and promoting the use of strategies to reduce recidivism based on evidence-based principles and practices, and programs which offer measurable and successful outcomes;
