**THIS AMENDMENT No. 1** is made and entered into by and between the County of Monterey, a political subdivision of the State of California, (hereinafter, "COUNTY"), and Binti, Inc. (hereinafter, "CONTRACTOR").

**WHEREAS**, the COUNTY and CONTRACTOR entered into an agreement for provision of licenses and support for Resource Family Approval software for a term of February 1, 2025 through January 31, 2027 with a total contract amount of \$56,936 (hereinafter, "Original Agreement").

**WHEREAS**, the parties wish to amend the agreement via Amendment No. 1 to add **\$7,996.73** with no change to contract term for a **revised** contract total of **\$64,932.97**.

**AGREEMENT**

**NOW THEREFORE**, the parties agree to amend the Agreement as follows:

This Agreement is hereby amended on the terms and conditions as set forth in the Original Agreement, incorporated herein by this reference, except as specifically set forth below.

1. **Page 1, "Order Form", Period 02/01/2025-01/31/2026, Fees:** is revised to **\$31,986.72**, for a revised total contract amount of **\$64,932.97**.
2. Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the Original Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Original Agreement.


