Additionally, CONTRACTOR shall coordinate their work with all other contractors whose work is affected by the scope of work defined in this Agreement. CONTRACTOR expressly agrees to provide appropriate labor, material and equipment in response to adjustments in the Project Schedule made by the Monterey County Director of Public Works or his/her designee during the course of the project in order to maintain the required progress.

ARTICLE 3. CONTRACT PRICE.

COUNTY shall pay CONTRACTOR as full consideration for the performance of the contract, INCLUSIVE OF THE BASE BID VALUE AND ADDITIVE ALTERNATES 1 AND 2A, subject to any additions or deductions as provided in the contract documents, the contract sum of ONE HUNDRED FORTY-SIX THOUSAND, EIGHT HUNDRED TWENTY-FIVE DOLLARS, (\$146,825).

ARTICLE 4. LIQUIDATED DAMAGES.

COUNTY shall notify CONTRACTOR of the receipt of any third-party claim relating to the contract and is entitled to recover its reasonable costs incurred in providing the notification as provided in Public Contract Code Section 9201.
