RENEWAL AND AMENDMENT No. 1 TO AGREEMENT COUNTY OF MONTEREY and WILLIAM AVERY & ASSOCIATES, INC.

- 1. The AGREEMENT is renewed retroactive to June 5, 2020, and all of its provisions shall be deemed to have been in effect continuously since that time.
- 2. Section 4.1, "TERM OF AGREEMENT," shall be amended by removing, "The initial term shall commence with the signing of this AGREEMENT and shall be for a period of five (5) years." and replacing it with, "The term is retroactive, to commence July 5, 2015, and continue through and including June 5, 2021."
- 3. Except as provided herein, all remaining terms, conditions, and provisions of the AGREEMENT, including all Exhibits thereto, are unchanged and unaffected by this RENEWAL AND AMENDMENT No. 1 and shall continue in full force and effect as set forth in the AGREEMENT.
- 5. A copy of this RENEWAL AND AMENDMENT NO. 1 shall be attached to the original AGREEMENT dated June 5, 2015 and incorporated therein as if fully set forth in the AGREEMENT.
