WHEREAS, on December 9, 2020, the Board of Supervisors identified the need to allocate additional funding to the Monterey County Workforce Development Board (MCWDB) to provide grants to additional applicants under its Monterey County Small Business Relief program (SBRP) due to the ongoing challenges affecting local small businesses; and

WHEREAS, the Budget Office has recommended the reallocation of Cannabis Tax Assignment funds or other funds identified by the Board;

NOW, THEREFORE, the Monterey County Board of Supervisors hereby resolved to approve authorizing and directing the Auditor-Controller to:

- a. Amend the FY2020-21 County Administrative Office Adopted Budget (021-1050-8478- CAO030) to increase appropriations by \$900,000 for the Monterey County Small Business Relief Program (administered by the Monterey County Workforce Development Board), financed by a release of Cannabis Tax Assignment funds (001-3132) or other funds identified by the Board (4/5th vote required);


