Elmer and Dorothy raised their three children, Richard, Ron, and Terre on the ranch; they have 8 grandchildren, 21 great-grandchildren, and 5 great-great-grandchildren. Elmer & Dorothy were married for 51 years; and,

WHEREAS, *Dorothy Skillicorn* and Elmer were very generous with the recreation room and swimming pool on their ranch. Since 1962 they have allowed various organizations and church groups use of their facility including Kiwanis, Lions, YMCA, Rainbow Girls, De Molay Boys, Japanese groups and Boy Scouts; and,

WHEREAS, *Dorothy Skillicorn* volunteered as a plane spotter watching enemy planes coming along the coast during World War II; and,

WHEREAS, *Dorothy Skillicorn* was active in many Watsonville clubs including the Pajaro Valley Historical Association, City of Watsonville Beautification committee, Watsonville Women's Club, Eastern Star, Red Cross, All Saints Episcopal Church, and she supported her children through 4-H. In 1991 Dorothy was honored as the Pajaro Valley Chamber of Commerce and Agriculture "Woman of the Year."
