**WHEREAS**, the County Counsel’s Office has an overall budget of \$49.6 million in current FY 22-23 and it is critical that the appropriate classification is allocated to perform the complex financial job duties of this position; and

**WHEREAS**, the essential job duties of the County Counsel’s Office Finance Manager I position has evolved with the Department’s business needs; and

**WHEREAS**, the Finance Manager I position performs complex financial job duties that are outside the scope of the current allocated classification; and

**WHEREAS**, the classification analysis determined and the Human Resources Department concurred that the duties, scope, and complexity of the proposed reallocation are most appropriately classified as a Finance Manager II;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors in and for the County of Monterey as follows:

1. The County Counsel’s Office - Budget Unit 1210-8407-Fund 001 -Appropriation Unit COU002 is amended to reallocate one 1.0 FTE Finance Manager I to one 1.0 FTE Finance Manager II as indicated below:


