WHEREAS, every day forty-three children are diagnosed with cancer, and more than 40,000 children undergo treatment for cancer in the United States of America each year; and

WHEREAS, in spite of progress in cancer research and treatment, more children die each year from cancer than asthma, diabetes, cystic fibrosis, congenital anomalies and AIDS combined; and

WHEREAS, families of children with cancer in Monterey County receive essential services from Jacob's Heart Children's Cancer Support Services, a local organization that has gained national awards and recognition for improving the quality of life for more than 550 local children with cancer and their families; and
