WHEREAS, The Monterey County Office of Emergency Services (MCOES) is the Federal Emergency Management Agency's designated Alerting Authority for the Operational Area (OA) of Monterey County; and

WHEREAS, The Monterey County Office of Emergency Services (MCOES) provides oversight and management of the Integrated Public Alert and Warning System (IPAWS) Alert Origination Software (AOS) Operational Area (OA) of Monterey County; and

WHEREAS, The Everbridge platform provides a mission critical function of public alert and warning for as the Alert and Origination Software (AOS) for the Operational Area (OA) of Monterey County; and

WHEREAS, The Monterey County Office of Emergency Services (MCOES) will be managing the Everbridge platform agreement, budget, and operations for the Operational Area (OA) of Monterey County; and

WHEREAS, on October 7th, 2022, the current Everbridge Amendment to the 2013 Agreement will end; and

WHEREAS, this new Everbridge Agreement would be in effect from October 8th, 2022 to October 7th, 2023; and

WHEREAS, the Auditor-Controller will amend the Fiscal Year 2022-2023 Adopted Budget for the Monterey County Office of Emergency Services (001-1050-CAO005-8056) to increase appropriations and estimated revenues by \$67,686, funded by participating jurisdictions of the 9-1-1 Services Agreement and collected by the Monterey County Emergency Communication's Department (ECD), 4/5th vote required.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Monterey hereby adopts this resolution:

- a. Approving and authorizing the Monterey County Office of Emergency Services to sign an Agreement for an Emergency Notification System between the County of Monterey and Everbridge Inc. in an amount not to exceed \$94,636.03 for a one-year term from October 8, 2022, to October 7, 2023; and
- b. Authorizing the Auditor-Controller to amend the Fiscal Year 2022-2023, Adopted Budget for the Monterey County Office of Emergency Services (001-1050-CAO005-8056), to increase appropriations and estimated revenues by \$67,686; the amount collected from participating local jurisdictions for their cost share of the Everbridge Agreement, 4/5th vote required.

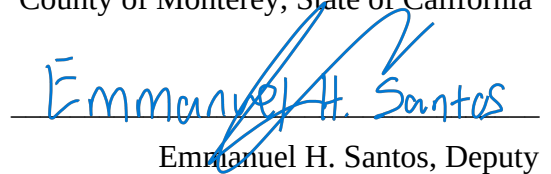
