# AMENDMENT NO. 4 TO SERVICES AGREEMENT BETWEEN PURESERVE BUILDING SERVICES, INC. AND THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER FOR

PROFESSIONAL BUILDING MAINTENANCE SERVICES

This Amendment No. 4 to the Services Agreement ("Agreement") which was effective on May 1, 2019 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Pureserve Building Services, Inc. ("CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

## RECITALS

**WHEREAS**, the Agreement was executed for Professional Building Maintenance Services with a term May 1, 2019 through April 30, 2020 and a total Agreement amount not to exceed \$64,116; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on April 21, 2020 via Amendment No. 1 to extend the term for an additional two (2) year period through April 30, 2022 to allow for services to continue with no changes to the scope of work or billing rates, with a \$130,000 increase for a total Agreement amount to \$194,116; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on May 1, 2022 via Renewal and Amendment No. 2 to include new CONTRACTOR obligations, to extend the term for an additional two (2) year period through April 30, 2024, and to increase the total amount of the Agreement to \$333,116; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on November 16, 2022 via Amendment No. 3 to allow for services to continue with an additional scope of work attached hereto as "Exhibit B per Amendment No. 3", with a \$60,000 increase for the added services for a total Agreement amount of \$393,116, with no change to the agreement term of May 1, 2019 through April 30, 2024; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period (May 1, 2024 through April 30, 2025) for a revised full agreement term of May 1, 2019 through April 30, 2025 with a \$133,684 increase for a total Agreement amount of \$526,800.

## **AGREEMENT**

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No. 1, Renewal and Amendment No. 2, and Amendment No. 3 incorporated herein by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, "PAYMENTS BY COUNTY" shall be amended to the following: "The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$526,800."

- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 4 and shall continue in full force and effect as set forth in the Amendment No. 1, Renewal and Amendment No. 2 and Amendment No. 3.
- 3. A copy of this Amendment No. 4 shall be attached to the Agreement.
- 4. This Amendment No. 4 shall be effective when both parties have signed.
