WHEREAS, Wayne Clark Ph.D., began his career in California in 1973 with the San Francisco Health Department where he served for fifteen years as the Director of Community Substance Abuse Services and the Assistant Director for Mental Health Services for ten years, participating in numerous SAMHSA and NIH research grants; and

WHEREAS, Wayne Clark, Ph.D., became Monterey County Behavioral Health Director in May 2002 and developed a team of highly qualified clinicians and managers; and

WHEREAS, Wayne Clark, Ph.D., provided leadership and oversight of a Behavioral Health Bureau that tripled in size during his tenure; and

WHEREAS, Wayne Clark, Ph.D., expanded and opened four new Behavioral Health clinics, collaborated with the Monterey Office of Education to expand school mental health services, worked closely with community-based nonprofits to expand supportive housing for the homeless, invested in a new graduate program at CSUMB that has recruited and educated future bilingual social workers, and successfully oversaw the integration of Primary Care Services with the Behavioral Health Bureau; and

WHEREAS, Wayne Clark, Ph.D., created a community-wide stakeholder and planning process in Monterey County that implemented Proposition 63 *the Mental Health Service Act* which enhanced and expanded Behavioral Health Services and reached out to underserved populations; and

WHEREAS, Wayne Clark, Ph.D., collaborated with the Probation Department, Social Services Department, the District Attorney's Office, the Monterey County Office of Education, and community based non-profits to establish and sustain the Silver Star Resource Center and actively participated in the formation of the Community Alliance for Safety and Peace, *CASP*.

WHEREAS, Wayne Clark, Ph.D., will retire from the County of Monterey on March 3, 2015, after an outstanding career of service to the community.

NOW, THEREFORE, BE IT RESOLVED that the Monterey County Board of Supervisors on behalf of the County and all of its citizens thereof, hereby acknowledges, and commends **Wayne Clark, Ph.D.**, for the excellent performance of his duties as the Behavioral Health Bureau Chief and his concern with meeting the needs of the community of Monterey County, and wishes him success and contentment in his retirement.
