 - a) Why were product and/or vendor chosen?
 Existing IDEMIA Maintenance and Support Agreement is reaching Term on 6/30/2024.

Endpoint IDEMIA devices need to be under 24/7 support and maintenance. IDEMIA has furnished all the parts and components necessary for the service and maintenance of the System. To abandon existing support would result in a major disruption of services, officer safety issues and introduce compliance issues when booking inmates at the county jail.
