**WHEREAS,** upon his retirement, Mr. Roberti sold the business to his granddaughter and her husband, Anna & Carlo Cortopassi. Carlo Cortopassi, his son, Paul, and his daughter Cindy, operate **CASTROVILLE PLUMBING & HEATING, INC.** today; and

**WHEREAS, CASTROVILLE PLUMBING & HEATING, INC.** is celebrating its 80<sup>th</sup> anniversary of giving three generations of excellent service to the North County community and supporting many community groups such as: the Artichoke Festival, Relay for Life, North County Bulldogs, North County Little League, North County Recreation & Park District, North County High School, Our Lady of Refuge Parish, Palma School Notre Dame School, Sacred Heart School, Madonna del Sasso School, Rotary Club of Castroville, Castroville Jaycees, North County Chamber of Commerce, Peace in the Streets and Monterey County P.A.L.
