Dry Period Loan for Fiscal Year 2014/2015

WHEREAS, the Board of Directors of Soledad-Mission Recreation District find that, until its tax revenue is received, it will not have sufficient funds to pay its obligations incurred for maintenance purposes in the current fiscal year, and whereas its funds are in the custody of the Treasurer of the County of Monterey and are paid out solely through his/her office;

NOW THEREFORE BE IT RESOLVED THAT, pursuant to Article 13, Section 25 of the California Constitution, the Treasurer of the County of Monterey to make a temporary transfer to said district, from the funds in his/her custody, in the sum of \$39,000.000 which is necessary to provides funds for meeting obligations incurred for maintenance and operations purposes;

BE IT FURTHER RESOLVED THAT, Lori Bush, Board President, is authorized and directed to make and sign a request for said transfer and to send a copy of the resolution to the County Treasurer.
