WHEREAS, the Human Resources Department conducted a classification study of an incumbent in the Administrative Services Assistant classification in the Emergency Communications Department; and

WHEREAS, the study found that the Administrative Services Assistant classification does not accurately reflect the duties and responsibilities that the incumbent is performing and that the appropriate classification is the Management Analyst I classification; and

WHEREAS, it is recommended that one (1) Administrative Services Assistant position be reallocated to a Management Analyst I position and the incumbent be reclassified from an Administrative Services Assistant to a Management Analyst I;

WHEREAS, to implement the recommendation, the action requires the FY 2025-26 Adopted Budget to be amended;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:

1. The Emergency Communication Department Budget Unit 1520-8507-Fund 028 is amended to reallocate and approve the reclassification of one (1) Administrative Services Assistant to one (1) Management Analyst I as indicated below:


