**WHEREAS**, July 29, 2021, Monterey County was allocated one-time funds of \$1,796,632 by California Department of Social Services to continue providing Project Roomkey(PRK) emergency non-congregate shelter protective placements and rehousing strategies that support clients moving into permanent housing through June 30, 2022; and

**WHEREAS**, Social Services is partnering with the City of Salinas to re-open the PRK program that ended on August 31, 2021, providing program oversight up to 40 motel rooms within the City of Salinas; and

**WHEREAS**, City of Salinas is committing \$3 million of American Rescue Plan Act funding towards this project assisting City of Salinas residents and the County’s funding will cover residents from other areas of the County; and

**WHEREAS**, an increase in appropriations and estimated revenues are required in the Social Services Community Programs FY 2021-22 Adopted Budget 001-5010-SOC004-8258 in the amount of \$1,796,632; and

**WHEREAS**, the Board of Supervisors will need to authorize and direct the Auditor Controller to amend the FY 2021-22 Adopted Budget by increasing appropriations and revenues by \$1,796,632 in the Social Services Community Programs Budget Unit 001-5010-SOC004-8258

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Supervisors of the County of Monterey hereby:

- 1. Approved an increase in appropriations and revenues of \$1,796,632 for the Social Services Community Programs Budget Unit 001-5010-SOC004-8258 FY 2021-22 Adopted Budget to partner with City of Salinas to provide non-congregate shelter, wraparound services, and rapid re-housing to homeless individuals.

2. Authorized and directed the Auditor-Controller to amend the FY 2021-22 Adopted Budget by increasing appropriations and revenues by \$1,796,632 in the Social Services Community Programs Budget Unit 001-5010-SOC004-8258.
