AMENDMENT #2 TO AGREEMENT

WHEREAS, Social Policy Research Associates Inc., hereinafter called "CONTRATOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY" previously entered into an agreement dated December 18, 2012, for the provision of consultant services ("AGREEMENT"); and

- 1. "EXHIBIT-A Scope of Services" shall be amended with "Exhibit A-2 Additional Scope of Services" which includes additional services requested by the County. The County shall pay CONTRACTOR in accordance with the payment provisions set forth in the revised Scope of Services attached hereto as "Exhibit A-2 Additional Scope of Services";
- 2. PAYMENT PROVISIONS: Section 2, shall be amended by adding Exhibit A-2 and increasing the payment amount \$135,998 by an additional \$42,486 for a total compensation of a not to exceed amount of \$178,484 for the term of the AGREEMENT.
- 3. Accept as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment NO. 2 and shall continue in full force and effect as set forth in the AGREEMENT.
- **4.** A copy of this AMENDMENT NO. 2 shall be attached to the original AGREEMENT dated December 18, 2012; AMENDMENT NO. 1 dated April 22, 2013.
