

**AMENDMENT NO. 1  
TO SERVICES AGREEMENT  
BETWEEN Per Diem Staffing Systems Inc. AND  
NATIVIDAD MEDICAL CENTER  
FOR  
ANCILLARY REGISTRY SERVICES**

This Amendment No. 1 to the Master Services Agreement per the Request for Proposals; RFP #9600-22 ("Agreement"), dated August 1, 2012 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and **Per Diem Staffing Systems Inc.** (hereinafter "CONTRACTOR"), with respect to the following:

**RECITALS**

**WHEREAS**, the Agreement was executed for Ancillary Registry Services per RFP #9600-22 with a three year initial term and a total Agreement amount not to exceed \$3,600,000 for all contracts under the Master Agreement; and

**WHEREAS**, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional twelve month period through June 30, 2016 to allow for services to continue with a \$2,700,000 increase for the extended term period and for a total Master Agreement amount of \$6,300,000 for all contracts under the Master Agreement.

**AGREEMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in Original Agreement incorporated herein by this reference, except as specifically set forth below.

1. Section 5.1, "Term of Agreement" shall be amended to the following;

*"The term of the Agreement is August 1, 2012 through June 30, 2016 with the option to extend the Agreement for one (1) additional one (1) year period at the end of the term. NMC is not required to state a reason if it elects not to renew this Agreement. "*

2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement
3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
