

**AMENDMENT NO. 1  
TO SERVICES AGREEMENT  
BETWEEN EMPLOYNET, INC. AND

TEMPORARY EMPLOYMENT SERVICES**

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on September 27, 2021 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Employnet, Inc. ("CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

**RECITALS**

**WHEREAS**, the Agreement was executed for temporary employment services with a term September 27, 2021 through September 26, 2022 and a total Agreement amount not to exceed \$100,000; and

**WHEREAS**, COUNTY and CONTRACTOR currently wish to amend the Agreement via Amendment No. 1 to extend the term for an additional ~~two (2)~~ <sup>two (2)</sup> month period through December 26, 2022 for a revised term Agreement September 27, 2021 through December 26, 2022 to allow for services to continue with no change to the scope of services or pricing structure, with a \$150,000 increase for a total Agreement amount of \$250,000.

**AGREEMENT**

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

1. Section 2, "PAYMENTS BY COUNTY" shall be amended to the following:  
***"COUNTY shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A, subject to the limitations set forth in this Agreement. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$250,000."***
2. The first sentence of Section 3, "TERM OF AGREEMENT" shall be amended to the following:  
***"The term of this Agreement is from September 27, 2021 through December 26, 2022 unless sooner terminated pursuant to the terms of this Agreement."***
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
4. A copy of this Amendment No. 1 shall be attached to the Agreement.
5. This Amendment No. 1 shall be effective when signed by both Parties.
