Upon motion of Supervisor Adams, seconded by Supervisor Alejo and carried by those members present, the Board of Supervisors hereby:

- a. Authorized the Deputy Purchasing Agent for Natividad Medical Center (NMC) or his designee to execute Renewal and Amendment No. 2 to the Agreement with Qventus (formerly known as Analytics MD, Inc.) for operational decision support software at NMC to extend the Agreement term for two (2) additional years (October 29, 2017 through October 28, 2019), for a revised full term of October 29, 2015 through October 28, 2019 and increasing the amount by \$190,000 for a revised total agreement amount not to exceed \$381,000.
- b. Authorized the Deputy Purchasing Agent for NMC or his designee to execute up to three (3) future amendments to the agreement which do not significantly alter the scope of work and do not cause an increase of more than ten percent (10%) (\$19,100) of the original cost of the agreement in total.

Renewal and Amendment No. 2
To Qventus (formerly known as AnalyticsMD Inc.) Software Services Agreement
By and between Qventus
and Natividad Medical Center

This Renewal and Amendment No. 2 to the Services Agreement (“Agreement”) which was effective on October 29, 2015 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter “NMC”), and Qventus, formerly known as AnalyticsMD Inc., (hereinafter “CONTRACTOR”); (collectively, the County, NMC and CONTRACTOR are referred to as the “Parties”), with respect to the following:

WHEREAS, NMC and CONTRACTOR entered into an Agreement for CONTRACTOR to provide NMC with the license to use its operational decision support software system for the term of October 29, 2015 through October 28, 2016 and a total Agreement amount not to exceed \$91,000; and

WHEREAS, that Agreement expired on October 28, 2016; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on January 24, 2017 via Renewal and Amendment No. 1 to extend the term for an additional one (1) year period through October 28, 2017 with no additions to the original scope of work and to add an additional \$100,000, thereby increasing the Agreement amount to \$191,000; and

WHEREAS, that Agreement expired on October 28, 2017; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional two (2) year period through October 28, 2019 to allow for services to continue with additions to the original scope of work attached hereto as “Exhibit A-2 per Renewal and Amendment No. 2” with a \$190,000 increase for the added services for a total Agreement amount of \$381,000.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Software Services Agreement, in Renewal and Amendment No. 1, and Renewal and Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

1. The parties hereby agree to add **Order Form #003** attached hereto for Qventus Software License for an additional cost of \$190,000 during the period 10/29/17 – 10/28/19, for a revised total Agreement amount not to exceed \$381,000.
2. The second sentence of Section 21 titled, “TERM AND TERMINATION” shall be amended to the following:
“The term of this agreement is from October 29, 2015 through October 28, 2019 unless sooner terminated pursuant to the terms of this Agreement.”

3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Renewal and Amendment No. 2 and shall continue in full force and effect.
4. A copy of this Renewal and Amendment No. 2 shall be attached to the Original Agreement.
5. This Renewal and Amendment No. 2 shall be effective retroactively on October 29, 2017.





DESCRIPTION OF EMERGENCY DEPARTMENT FLOW MODULE

Qventus is a web-based subscription service that uses machine learning and decision science to provide specific data driven decisions in real time. In addition, the product allows staff to visualize and monitor relevant metrics “on the fly.” The service is delivered over the web in a software-as-a-service form. The Service that will be provided to Customer will be comprised of the following components that each provide specific functionality:

- Air Traffic Control / Decision Layer
 - The decision layer is an automated forecast-and-decide system that evaluates real-time data, forecasts the short term implications, and evaluates a set of potential actions to make a recommendation to the manager
 - These decisions use machine learning and optimization algorithms to determine the best course of action based on predicted demand. Specific decisions recipes to be implemented by Qventus during the set up can be chosen from a library of decisions available and for the Customer Project. These may also include an unlimited number of recipes available as part of the ED FLOW module, at Customer’s option, if determined to be feasible by the Company. Example decisions include
 - Warning of impending surge
 - Opening up hallway beds in case of room capacity bottleneck
 - Informing greeter to check in with high likelihood LWBS patients
 - Process Monitoring: Monitor each flow step for a patient in the ER and inform managers if certain patients are waiting for an unusually long time. For example, if a patient’s discharge orders have been written but they haven’t been discharged
 - Recommending adding lab staff when labs slow down
 - The specific set of decisions to be implemented will be evaluated and decided by Customer during the ramp-up at the facility. Available recipes will include, but not be limited to ED Surge Warning, Delayed Discharge, Delayed Admit, Lab backup. Qventus will discuss these decisions with hospital administration to ensure all are practically feasible and acceptable to the hospital.
- Real Time Visualization
 - Dashboards with visualizations regarding Emergency Room Throughput. Visualizations can show both representations of process steps in the E.R. as well as key statistics relating to overall E.R. throughput performance
- Statistical Monitoring
 - Text and Email based alerts for managers and front line users when metrics deviate normal behavior
 - Users may freely opt-in to these alerts, which are delivered via SMS or e-mail
 - Statistical monitoring controls for time-series factors (seasonality, hour of day, etc.) as well as exogenous factors to alert staff only to truly abnormal events
 - All communications from Company to Client which contain protected health information shall be encrypted and compliant with the HIPAA regulations and minimum security standards set forth in this Agreement.
- Individualized Feedback
 - Individualized data feedback allowing doctors, nurses or departments to compare themselves against their peers
 - Feedback can be delivered through the product or over e-mail. Percentile scoring and anonymous ranks also available.
- Root Cause algorithms
 - This component allows users to understand if a metric is too high or low based on factors that may be out of control like acuity and patient volume
 - With a single click, the system will surface the most likely root causes as to why the metric may be deviating
 - Root cause algorithms can be configured to consider additional data streams not immediately related to the target department; for example, process flows in ancillary departments
