RECOMMENDATION:

It is recommended that the Board of Supervisors acting as the Board of Directors of the Pajaro County Sanitation District adopt a Resolution for the Pajaro County Sanitation District to certify compliance with State law with respect to the levying of general and specific taxes, assessments, and property-related fees and charges for the Pajaro County Sanitation District.

SUMMARY/DISCUSSION:

On July 9, 2024, the Board of Supervisors of the County of Monterey, acting as the Board of Directors of the Pajaro County Sanitation District, adopted Ordinance No. 5420, amending Section 16 of the Pajaro County Sanitation District (PCSD) Ordinance No. 05054 to provide for the collection of sewer charges through the County of Monterey (County) Property Tax Roll beginning with Fiscal Year 2024-25.

A Resolution has been prepared to collect annual PCSD sewer service charges on the County Property Tax Roll in compliance with State and County Requirements. As required, the Resolution contains a report of sewer service charges for the property owners of record in the PCSD (Attachment A).

OTHER AGENCY INVOLVEMENT:

Placement of annual assessments on the County Property Tax Roll is facilitated by the Auditor-Controller's Office.

FINANCING:

Internal expenses for the collection of sewer charges are minimal and include staff time to prepare the annual staff report to the Board of Supervisors and proposed Resolution. The Auditor Controller's Office charges administration costs of $\frac{1}{4}$ of 1% of revenue collected on the County Property Tax Roll. The estimated 2025-26 revenue from PCSD sanitation billing is \$1,589,776 resulting in an estimated charge by the Auditor-Controller of \$3,967.

WHEREAS, on July 9, 2024, the Board of Supervisors of the County of Monterey, acting as the Board of Directors of the Pajaro County Sanitation District, adopted Ordinance No. 5420, amending Section 16 of the Pajaro County Sanitation District (PCSD) Ordinance 05054 to provide for the collection of sewer charges through the Property Tax Roll for the County of Monterey beginning with FY 2024-25;

WHEREAS, this Resolution has been prepared, consistent with said PCSD Ordinance No. 5420 to provide for the collection of annual sewer service charges on the Property Tax Roll in compliance with State and County requirements;

WHEREAS, this Resolution contains a report of sewer service charges for the property owners of record in the jurisdictional boundaries of the PCSD which is attached and hereby incorporated by reference as Attachment A;

WHEREAS, the Auditor-Controller's Office enters those general or special taxes, assessments, or property-related fees for charges identified in Exhibit 1 on the Property Tax Roll for collection and distribution by the Monterey County Treasurer-Tax Collector commencing with the property tax bills for Fiscal Year 2025-26.

NOW, THEREFORE, the Board of Supervisors of the County of Monterey hereby resolves and certifies that:

- a. PCSD hereby certifies that it has, without limitation, complied with all legal procedures and requirements necessary for the levying and imposition of general or special taxes, assessments, or property-related fees or charges identified in Exhibit 1, regardless of whether those procedures and requirements are set for in the Constitution of the State of California, in State statutes, or in the applicable decisional law of the State of California; and
- b. PCSD shall be solely liable and responsible for defending, at its sole expense, cost and risk each and every action, suite, or other proceeding brought against the PCSD, its officers, employees, and agents for every claim, demand, or challenge to the levying or imposition of the general or special taxes, assessments, or property-related fees or charges identified in Exhibit 1 and that it shall pay or satisfy any judgment rendered against the PCSD, its officers, employees, and agents on every such action, suite, or other proceeding, including all claims for refunds and interest thereon, legal fees and court costs, and administrative expenses of the County of Monterey to correct the Property Tax Roll.

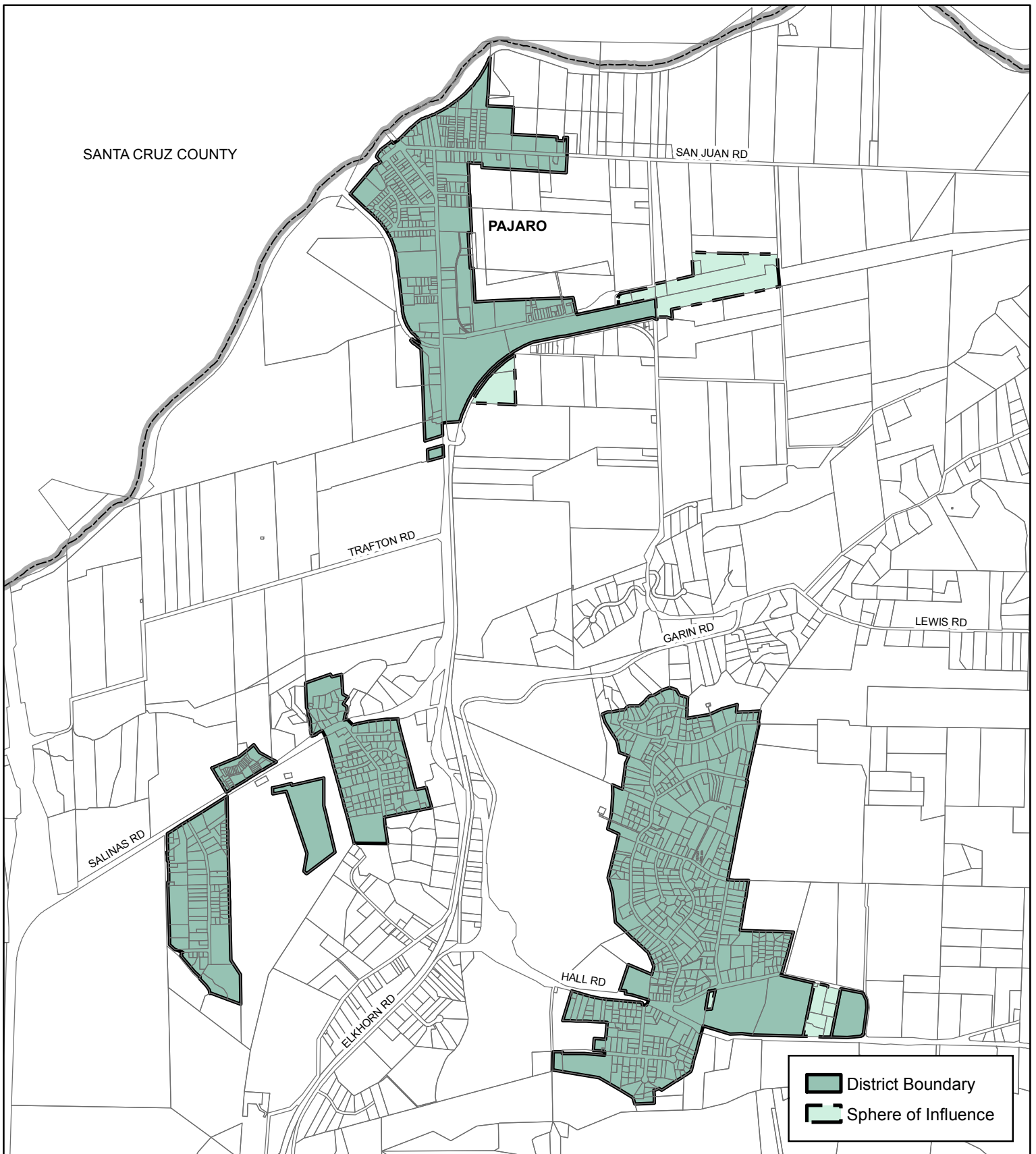

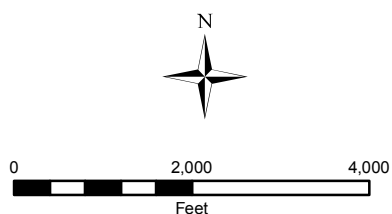
