

Hello Mary,

Thank you for reaching out. I appreciate your interest in learning more about our project. We always want to be sensitive about the impact of noise on our neighbors, so please know you can reach out to me directly anytime so we

can help troubleshoot any issues.

You are correct in that we have no plans for any new permanent speaker / lighting systems. The P.A. system you occasionally hear is only to be used a handful of times per year for emergency drills during school hours. And regarding the lights you mention, those are portable and seasonal in nature to allow our athletic programs to practice safely in the evenings when it gets dark so early. All of our practices should end by 7:00/7:30pm at the latest. We ask our coaches to direct the lights downward toward the field as much as possible, but we can take a look to see if there's anything we can do to minimize any lighting impact toward the river. And regarding the golf bays & batting cages, those are future improvements we're contemplating and are not part of this permit application. The school currently offers occasional golf and baseball/softball programming for our students, so the netted "cages/bays" would allow us to enhance the safety of this program.

Like you, we cherish the rural atmosphere here in Carmel Valley and aim to maintain that look and feel while keeping our students' safety in mind. Again, please don't hesitate to reach out to me anytime, and you are, of course, always welcome to come over to campus for a tour as well. It would be nice to meet you in person.
