#### **SUMMARY/DISCUSSION:**

The request for ratification is due to several factors, one being the timing of the event, and secondly the management firm was unable to secure the required services in a timely manner. The execution of the agreement prior to Board approval enabled the County to ensure a reliable source to provide video programs of the 2019 Rolex Monterey Motorsports Reunion event at the WeatherTech Raceway Laguna Seca. The Agreement was put in place while the Vendor was being properly registered in the County Advantage System. The term of the Agreement began August 1, 2019 and scheduled to terminate August 20, 2019. Work contracted under this Agreement shall not exceed \$130,847 in accordance with the terms and conditions set within the Agreement.
