### RENEWAL AND AMENDMENT #4 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND BINTI, INC.

**THIS RENEWAL AND AMENDMENT #4.** to the Agreement ("Agreement #A-14168") is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), and Binti, Inc. (hereinafter referred to as "CONTRACTOR") with respect to the following.

**WHEREAS**, on October 23, 2018, County and CONTRACTOR entered into Agreement #A-14168 in the amount of \$28,000 for the term October 23, 2018 through October 30, 2019 for the provision for licenses and support for Resource Family Approval software; and

**WHEREAS**, the parties amended the Agreement via Amendment #1 to extend the term through October 30, 2020 and add \$28,000 for a total contract amount of \$56,000.

**WHEREAS**, the parties amended the Agreement via Amendment #2 to extend the term through October 30, 2021, revise the Agreement language, and add \$28,840 for a total contract amount of \$84,840.

**WHEREAS**, the parties amended the Agreement via Amendment #3 to extend the term through October 30, 2022 and add \$29,705 for a new contract total of \$114,545.

WHEREAS, on October 30, 2022, Agreement #A-14168 expired by its terms; and

WHEREAS, the parties wish to renew and amend Agreement #A-14168 retroactive to October 30, 2022; and

**WHEREAS**, this Renewal and Amendment #4 is necessary due to County's continued need for CONTRACTOR's services; and

WHEREAS, the parties wish to extend the term of Agreement #A-14168 via Amendment #4 to extend the term through October 30, 2024 and add \$62,110.18 for a new contract total of \$176,655.18,

NOW THEREFORE, County and CONTRACTOR hereby agree as follows:

- 1. This Agreement #A-14168 is hereby renewed retroactive to October 30, 2022 and all of its prior terms and conditions shall be deemed to have been in effect continuously since that time.
- 2. Page 2, Section 4(a), Fees: This Amendment adds \$62,110.18 for the Renewal Term of October 30, 2022 through October 30, 2024. The new contract total is \$176,655.18.
- 3. Page 3, Section 6(a), Term: This Amendment extends the Original Agreement through October 30, 2024.
- 4. Exhibit D, Quote, is added, with the new renewal term of October 30, 2022 October 30, 2024 and the new contract total of \$176,655.18.
- 5. Except as provided herein, all remaining terms, conditions and provisions of the original Agreement are unchanged and unaffected by this Amendment #4 and shall continue in full force and effect as set forth in the original Agreement and in Amendment #1, Amendment #2, and Amendment #3.
- 6. A copy of this Renewal and Amendment #4 shall be attached to the Original Agreement.
