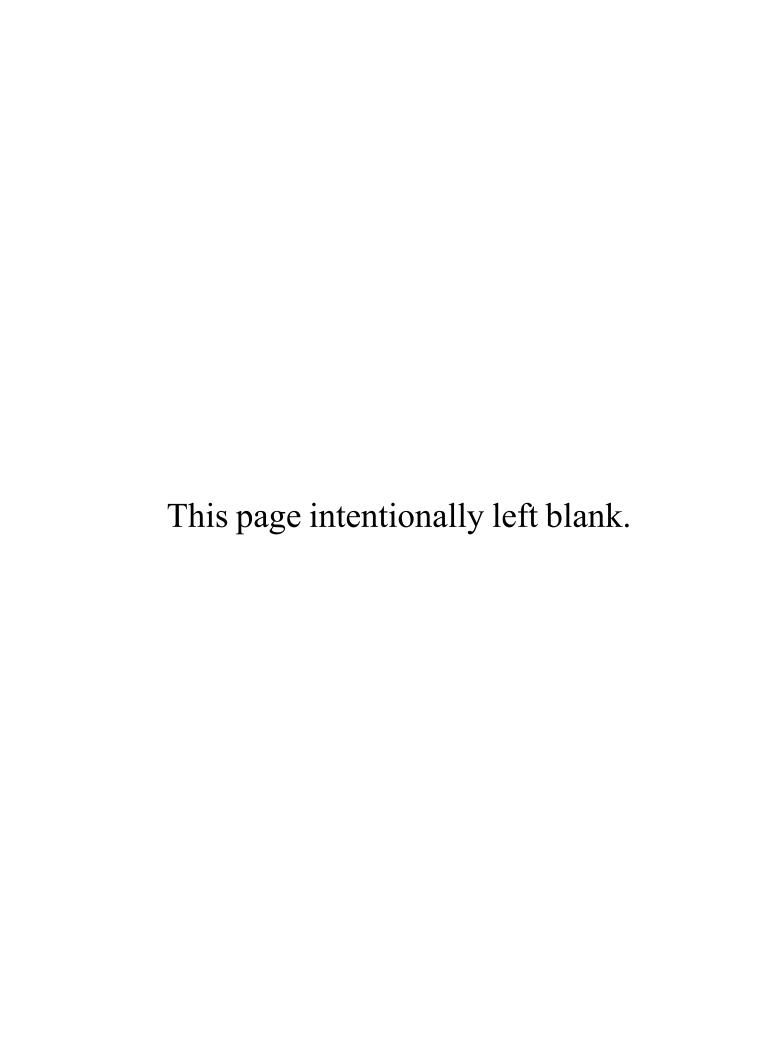




In the event there are proposed changes that my clients are unaware of, their position could change. However, given what has been represented to them, they are in support.


Hodge Pebble Beach - Landscape Site Plan - County Planning Application Plan with Current Design Overlay




Hodge Pebble Beach - Landscape Site Plan - County Planning Application Plan with Current Design Overlay
