obtain all non-criminal record services in the county at the marina or the Monterey Courthouse despite all the hardship they still face a grave Injustice committed not by anyone else but this case it was by a court Senate judicial council with these rankings so I'm glad that the president speaking up not staying silent and and doing everything possible to fight for what they deserve and I'm here with anniversary present Lopez made the track through traffic this morning with his hook constituents and I hooked up with that we can hopefully make a change with those rankings with the support of the center of the arrow and assembly member Robert Rivas so I think this is a glaring example one of the worst examples of poor people facing an injustice right here and I'll County this day in this year I don't got nothing I don't like to know how to do some we make significant progress on putting up the 5 Highway Memorial silence for our fallen veterans these were five of veterans killed in action in Afghanistan and the Monterey County supported legislation to put highway signs in five different stretches of Highways through Monterey County and we'll see what we got a date to available signs with the five gold star families and fellow veteran so one by the community to join us at the national Steinbeck Center on 3rd November 7th to pick up for several days of events honoring our veterans that these would be put the families who have a veterans appeal to men sacrificed our nation will be at 5:30 to 7 at the national tennis center room service I want to buy all my colleagues and Court employees and Community to join us to honor these veterans and he was an effort that by Monterey County
