Please find attached a resolution appointing Ray Bullick as Acting Director of Monterey County Health Department Behavioral Health Director. Ray Bullick is currently the Director of Health Services and will be replacing the retired Director Wayne Clark. In addition to serving as Acting Behavioral Health Director, Mr. Bullick will continue all his current duties and functions.

Please find attached a summary of Ray Bullick's background. Mr. Bullick has been working for Monterey County Health Department since June 2010.
