

## AMENDMENT #3 TO AGREEMENT

---

### AMENDMENT #3 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & MARK RISPOLI, DOING BUSINESS AS MAKOR K9

THIS AMENDMENT is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of canine and handler training for narcotics, explosives and patrol canines by and between MARK RISPOLI, DOING BUSINESS AS MAKOR K9, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on April 28, 2016 with a Not to Exceed amount of \$23,000 and a term date ending on April 4, 2017; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT with Amendment #1 on May 9, 2017 to increase the Not to Exceed amount to \$78,000 and extend term of AGREEMENT through April 4, 2019; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT with Amendment #2 on October 5, 2018 to increase the Not to Exceed amount to \$99,800 and extend term of AGREEMENT through April 4, 2020; and

WHEREAS, the County and CONTRACTOR wish to increase the AGREEMENT by \$56,000.00 for a new Not to Exceed sum of \$155,800.00 to provide funding through April 4, 2021; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to extend the Agreement for one (1) additional year through April 4, 2021.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 1., "PAYMENT PROVISIONS" shall be amended by removing, "*The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$99,800.00.*" and replacing it with, "*The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$155,800.00.*"
2. Section 3., "TERM OF AGREEMENT" shall be amended by removing, "*The term of this Agreement is from 4/5/2016 to 4/4/2020*" and replacing it with, "*The term of this Agreement is from 4/5/2016 to 4/4/2021*".
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.






