**AMENDMENT NO. 3
TO STANDARD AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
RESOURCE CONSERVATION DISTRICT OF MONTEREY COUNTY**

THIS AMENDMENT NO. 3 to Standard Agreement No. A-14107 between the County of Monterey, a political subdivision of the State of California (“County”) and Resource Conservation District of Monterey County (“CONTRACTOR”) is hereby entered into between the County and the CONTRACTOR (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Standard Agreement No. A-14107 with County on August 31, 2018 (“Agreement”) to provide staff and services to address a wide range of fire fuel mitigation issues and objectives (“services”) through June 30, 2019 for an amount not to exceed \$150,000;

WHEREAS, the Agreement was amended by the Parties on July 5, 2019 (“Amendment No. 1”) to extend the term for one additional year through June 30, 2020 and to update the 2018-19 Billable Rate Sheet with no increase in the not to exceed amount;

WHEREAS, the Agreement was amended by the Parties on May 19, 2020 (“Amendment No. 2”) to extend the term for one additional year through June 30, 2021 with no increase in the not to exceed amount;

WHEREAS, all tasks identified in Exhibit A of this Agreement have been completed;

WHEREAS, all funding for this Agreement has been expended;

WHEREAS, the County has a continued need for services and is currently seeking additional funds for this Agreement;

WHEREAS, additional time is necessary to allow County to seek additional funds to allow CONTRACTOR to continue to provide services required by the County;

WHEREAS, the Parties wish to further amend the Agreement to extend the term for one additional year to June 30, 2022 with no associated dollar amount increase.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3.01 of Section 3.0, “Term of Agreement”, to read as follows:

The term of this Agreement is from August 28, 2018 to June 30, 2022, unless sooner terminated pursuant to the terms of this Agreement.

2. Add the following sentence to the second paragraph of Section A.1 of Exhibit A - Scope of Services/Payment Provisions:

CONTRACTOR shall not provide additional services beyond June 30, 2020 until additional funds are made available to the County and County issues CONTRACTOR a notice to proceed.

3. Amend County information in Section 14.0 “Notices” to read as follows:

4. In all places within the Agreement, any reference to County’s email address of RMA-Finance-AP@co.monterey.ca.us for invoicing, is hereby replaced with 194-HCD-Finance@co.monterey.ca.us.
5. All references to the Resource Management Agency (RMA) in the Agreement or Amendment Nos. 1 and 2 shall be understood to mean Housing and Community Development (HCD) to the extent applicable.
6. Except as amended herein, all other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force and effect.
7. This Amendment No. 3 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

IN WITNESS WHEREOF, the Parties hereto have executed this Amendment No. 3 to the Agreement which shall be effective as of the last date opposite the respective signatures below.
