## RENEWAL AND AMENDMENT NO. 1 TO AGREEMENT BETWEEN COUNTY OF MONTEREY AND HAYASHI AND WAYLAND ACCOUNTING AND CONSULTING, LLP

THIS RENEWAL AND AMENDMENT NO. 1 to Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and HAYASHI AND WAYLAND ACCOUNTING AND CONSULTING, LLP. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into an Agreement with County on July 1, 2019 (hereinafter, "Agreement"), for the provision of providing Auditing Services for the Office of the District Attorney, an amount not to exceed \$69,750.00; and

WHEREAS, the Agreement expired pursuant to its terms on June 30, 2021; and

WHEREAS, the Parties wish to renew the Agreement retroactive to July 1, 2021; and

WHEREAS, the County has a continued need for services; and

WHEREAS, the Parties wish to extend the term of the renewed Agreement for three (3) additional years through December 31, 2024 and to increase Agreement amount by \$80,430.00 to a new total not to exceed amount of \$150,180.00 to allow CONTRACTOR to continue to provide services identified in this Agreement and as amended by this RENEWAL AND AMENDMENT NO. 1.

## NOW THEREFORE,

For valuable consideration, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. The Agreement is renewed retroactive to July 1, 2021, and all of its provisions shall be deemed to have been in effect continuously since that time.
- 2. Amend Paragraph 2.01 of Section 2.0, "Payment Provisions", to read as follows:

County shall pay the CONTACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by the County to CONTRACTOR under this Agreement is not to exceed the sum of \$150,180.00.

3. Amend Paragraph 3.01 of Section 3.0, "Term of Agreement", to read as follows:

The term of this Agreement is from July 1, 2019 to December 31, 2024, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect

- 5. A copy of this RENEWAL AND AMENDMENT NO. 1 shall be attached to the original Agreement dated July 1, 2019.
- 6. The recitals to this RENEWAL AND AMENDMENT NO. 1 are incorporated by this reference.
