Recommended Actions

Adopt and authorize the Housing Program Manager to submit the 4th Substantial Amendment to the FY2019-20 Action Plan to HUD and execute all required documents.

Authorize the Housing Program Manager to execute Subrecipient Agreements with the Agencies identified in Attachment A in the form of the attached Draft Subrecipient Agreement.

Background

CDBG-CV1

- ▶ April 2020 – Urban County notified of 1st award of CARES Act funding
- ▶ May 19, 2020 – Board of Supervisors authorizes funding:
 - ▶ Eden Council for Hope & Opportunity
 - ▶ Food Bank for Monterey County;
 - ▶ Legal Services for Seniors
 - ▶ Meals on Wheels of the Salinas Valley
 - ▶ United Way

CDBG-CV3

- ▶ September 2020 – Urban County notified of 2nd award of CARES Act funding
- ▶ January 2021 – Board of Supervisors approves use of all CV3 funding for Emergency Rental Assistance
- ▶ March 2021 – County receives \$27 million in other funding specifically for Emergency Rental Assistance
- ▶ April 2021 – Urban County circulates new NOFA for CDBG-CV3 funding
