AMENDMENT NO. 4 TO THE AGREEMENT BETWEEN THE COUNTY OF MONTEREY AND

ONE WORKPLACE L. FERRARI, LLC, DBA PENINSULA BUSINESS INTERIORS

This Amendment No. 4 to Agreement, No. A-14396, is made and entered into by and between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and One Workplace L Ferrari, LLC, DBA Peninsula Business Interiors, hereinafter referred to as "CONTRACTOR."

WHEREAS, the COUNTY and CONTRACTOR entered into Agreement A-14396 with a start date of July 1, 2019 in an amount not to exceed \$200,000 for the provision of design, planning, delivery and installation services for new or existing office furniture or office panel systems on a per project basis; and

WHEREAS, the COUNTY and CONTRACTOR entered into AMENDMENT No. 1 to extend the term for an additional two (2) year period for a new term of July 01, 2019 through June 30, 2023 and to increase the total amount of the Agreement to \$500,000 to cover additional goods and services due to the extended term; and

WHEREAS, the COUNTY and CONTRACTOR entered into AMENDMENT No. 2 to extend the term for an additional two (2) year period for a new term of July 01, 2019 through June 30, 2025 and adding \$150,000 to increase the total amount of the Agreement to \$650,000 to cover additional goods and services due to the extended term; and

WHEREAS, the COUNTY and CONTRACTOR entered into AMENDMENT No. 3 to add \$250,000 to increase the total amount of the Agreement to \$900,000 to cover additional goods and services for planned and future projects; and

WHEREAS, the COUNTY and CONTRACTOR wish to amend AGREEMENT to add \$3,000,000 to increase the total amount of the Agreement to \$3,900,000 to cover additional goods and services for planned and future projects.

NOW THEREFORE, both parties hereby agree to renew and amend the Agreement as follows:

- 1. **Section 2.0, "PAYMENT PROVISIONS",** shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$900,000" **and replacing it with** "The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$3,900,000."
- 2. All other terms and conditions of the Agreement remain unchanged and in full force. This Amendment No. 4 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

- 3. A copy of this Amendment No. 4 shall be attached to the original Agreement executed by the County on July 05, 2019.
- 4. This Amendment No. 4 is effective upon execution.
