

AMENDMENT No. 1 to the Professional Services Agreement between Apex Software and the County of Monterey (Assessor)

THIS AMENDMENT is made to the County of Monterey Agreement for PROFESSIONAL SERVICES AGREEMENT, is made and entered, by and between the County of Monterey, a political subdivision of the State of California (hereinafter, "COUNTY"), and Apex Software (hereinafter, "CONTRACTOR") (collectively, the COUNTY and CONTRACTOR are referred to as the "parties").

WHEREAS, the parties had previously entered into an Agreement for Professional Services (hereinafter, "Agreement"), with a term of July 1, 2014 through June 30, 2015; and

WHEREAS, the parties desire to amend that Agreement, on the same or similar terms, for the period July 1, 2015 through June 30, 2016; and

WHEREAS, this Amendment is necessary due to the needs of the Assessor's office to continue to draw blueprints without interruption in the current workload and to eliminate the creation of a backlog.

NOW THEREFORE, the Parties agree as follows:

1. The Agreement is hereby amended and extended to include the period July 1, 2015 to June 30, 2016, unless sooner terminated pursuant to the terms of the Agreement or extended in writing by the parties.
2. The total amount payable by COUNTY to CONTRACTOR for all services performed during the period of July 1, 2015 to June 30, 2016 shall not exceed the sum of \$3,210, pursuant to the attached invoice.
3. If there is any conflict or inconsistency between the provisions of the Agreement, or this Amendment, the provisions of this Amendment shall govern. A copy of this Amendment shall be attached to the original Agreement. Except as provided herein, all other terms, conditions, provisions, entitlements and obligations of the original Agreement shall remain unchanged and unaffected by the Amendment and shall continue in full force and effect.

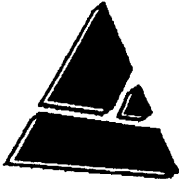

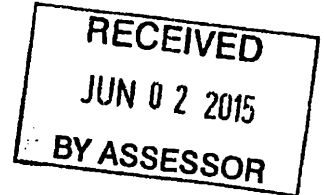
