**WHEREAS**, over 90 years ago, Jay Lynn opened Lynn's Food Center on the 200 block of Broadway; and

**WHEREAS**, in 1945, Jay's son Jim Lynn purchased the Top Hat Bar, Top Hat Liquors and the Vendome Hotel in the 300 block of Broadway, thereafter serving as gathering places for townspeople and travelers, and known for service and care of their customers; and

**WHEREAS**, in 1959, Jim Lynn moved the liquor business to 432 Broadway, naming it Lynn's Liquors, where it became the stopping place for all of King City and known for the best of service to its customers; and

**WHEREAS**, in 1970 Jim's son, Byron Lynn, returned to King City after graduating from Arizona State University and became the owner of Lynn's Liquors, and in 1977, Byron opened Lynn's Liquors and Deli at 601 Broadway, then becoming the go-to place for morning coffee, sandwiches and deli platters; and

**WHEREAS**, in 2000, Byron Lynn opened Lynn's Too at 1137 Broadway, where he and his great employees have served locals and freeway travelers with gas, coffee, beverages and snacks; and

**WHEREAS**, **Lynn's Too!**, Byron and Melanie Lynn have always been known for their generosity, community involvement, and willingness to go above and beyond; and

**WHEREAS**, **Lynn's Too!** has made great contributions to our community, created a great working environment for their employees and truly deserves to be recognized as the **King City Chamber of Commerce and Agriculture's 2017 Business of the Year**.
