Qiagen, LLC, hereinafter referred to as “CONTRACTOR”

Scope of Services / Payment Provisions

A. SCOPE OF SERVICES

A.1 CONTRACTOR shall provide services and staff, and otherwise do all things necessary for or incidental to the performance of work, as set forth below:

The services to be provided pursuant to this agreement between the County of Monterey and Qiagen, LLC, is for the purchase and installation of EZ1 Advanced XL PrioPLUS instrument, EZ1 adv. XL DSP Virus card software and EZ1, IQ/OQ service, maintenance, and for related training services.

A.1.1 CONTRACTOR shall install EZ1 Advanced XL, PrioPLUS instrument and software to include the following:

- a. On-site installation provided by certified QIAGEN specialist
- b. Set-up of the instrument hardware
- c. Installation of the system software

A.1.2 CONTRACTOR shall provide one (1) training on EZ1 Advanced XL, PrioPLUS for a group maximum of four (4) laboratory staff to include:

- a. Introduction to the instrument and capabilities
- b. Operations of the instrument
- c. Demonstration of the graphical user interface/software
- d. Practice run set-up
- e. Run customer supplied samples (if applicable)
- f. Maintenance
- g. Troubleshooting
- h. Resources

A.1.3 CONTRACTOR shall provide documentation and certification upon completion of training and installation as follows: Documentation of service in accordance with GMP/GLP requirements

- a. Checklist of training topics
- b. Training certificates for participants

A.1.4 CONTRACTOR shall provide -three (3) one-year warranty on parts and labor on EZ1XL, PrioPlus.

A.1.5 CONTRACTOR shall provide three (3) annual preventative maintenance visits for XL EZ1 Advanced PrioPLUS.

A1.6 CONTRACTOR shall provide IQ/OQ service at the time of installation of EZ1 Advanced XL PrioPlus. The price for EZ1 IQ/OQ service, described below in Section B is inclusive of costs for installation, labor, and travel.

County shall not pay any claims for payment for services submitted more than twelve (12) months after the calendar month in which the services were completed.

DISALLOWED COSTS: CONTRACTOR is responsible for any audit exceptions or disallowed costs incurred by its own organization or that of its subcontractors.
