WHEREAS, each year the County of Monterey and County Veterans Services Advisory Commission Honors those who have made a significant contribution in their communities, are strong motivators, have demonstrated extraordinary professional competence and are strong role models for Veterans and the community as a whole; and,

WHEREAS, the Military and Veterans Services Advisory Commission is honored to recognize *Robert L. Adams* as a Monterey County "Veteran of the Year" for the year 2013; and,

WHEREAS, *Robert L. Adams* served in the 82nd Airborne Division out of Ft. Brag Kentucky, 101st Airborne Division (Viet Nam), 525 Military Intelligence Battalion (Viet Nam), 572nd Military Intelligence Detachment (Viet Nam), 101st Airborne Division Fort Campbell Kentucky, 8th Infantry Division (Germany), and 27th Field Artillery (Germany). He retired at Fort Ord in 1991 as Chief Warrant Officer with the United States Army; and,

WHEREAS, *Robert L. Adams* is past President of the United States Warrant Officers Association; and,

WHEREAS, *Robert L. Adams* is a life member of the VFW. He served 4 terms as Commander of the American Legion Post 3 where he served on the Executive Board for 17 years; and, is currently serving as Post Judge Advocate. He was instrumental in establishing the Honor Guard at Post 31 and for starting Friday night dinner service as the fundraiser for the Post, Auxiliary; and,

WHEREAS, *Robert L. Adams* served 4 years as Charter Organization rep for Boy Scout Troop 232 who provided food services for the Monterey County Veterans Stand Down, serving over 1000 meals a day for 4 days. He also cooked and served meals for the Ride 2 Recovery which fed 200 wounded warriors; and,

WHEREAS, *Robert L. Adams* has cooked, shopped, and transported food to the Palo Alto VA hospital Spinal Cord and Blind Ward for Thanksgiving and Christmas dinners for the past 10 years; and,

WHEREAS, *Robert L. Adams* has been involved in the Community Thanksgiving dinner at American Legion Post 31 for the past 20 years where they have served free meals to approximately 400-500 people in the community.

NOW, THEREFORE BE IT RESOLVED, that the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, recognizes and honors *Robert L. Adams* on the occasion of him being selected as one of the Monterey County Military and Veterans Services Advisory Commission's "Veteran of the Year" for 2013 and wishes him continued success, peace and happiness in all of his future endeavors.
