Board Order

Motion 1. Upon motion of Supervisor Adams, seconded by Supervisor Parker:

- a. Conducted a public hearing to consider an appeal filed by General Farm Investment (Chris Bunn) of the denial by the Monterey County Department of Health of General Farm Investment's application for a Water Well Construction Permit (#17-12916) for Assessor's Parcel Number 414-011-001, at Cooper Road and McFadden Road; and
- b. Directed staff to give the applicant a conditional permit that would be held in advance for 2 or 3 years while we allow the look of CSIP moving toward their property and giving the GSA more of an opportunity to get the work done that they need to.

- a. Conducted a public hearing to consider an appeal filed by General Farm Investment (Chris Bunn) of the denial by the Monterey County Department of Health of General Farm Investment's application for a Water Well Construction Permit (#17-12916) for Assessor's Parcel Number 414-011-001, at Cooper Road and McFadden Road;
- b. Granted the appeal and approved the well as a Replacement well with conditions. The well being replaced is properly destroyed under permit; subject to the conditions that were listed and adding the condition for metering, monitoring and reporting for the GSA purpose, and General Farm Investment to accept, implement and adhere to Board of Supervisors' approved conditions as recommended by the groundwater sustainability working group; and
- c. The Board adopted a motion of intent with appropriate findings and evidence and legislative documents pursuant to the Board of Supervisors' direction, and continued the hearing to a date certain to enable staff to return with a resolution with findings and evidence supporting the decision.
