WHEREAS, Commander Christopher Pascone has served as a respected Deputy Sheriff for Monterey County for over thirty-one years. He was born and raised in Los Angeles, California and at the age of 18 years began serving in the United States Army as a military paralegal; and

WHEREAS, upon his honorable discharge from the military as a Sergeant, on September 2, 1980 Commander Pascone began his career with Monterey County as a Court Clerk in the Monterey Municipal Court simultaneously pursuing his college education; and

WHEREAS, Commander Pascone was hired by the Monterey County Sheriff's Office on September 21, 1981 as a Deputy Sheriff and was sworn in by then Sheriff D.B. "Bud" Cook. Over his lengthy career he has served under five Monterey County Sheriffs: D.B. "Bud" Cook, Norman Hicks, Gordon Sonne, Mike Kanalakis and Scott Miller; and

WHEREAS, Commander Pascone served as a Deputy Sheriff and Facility Training Officer in the Main Jail and Rehabilitation Center from 1983 until 1990. Following his promotion to Sergeant in 1990, his supervisory assignments included the Rehabilitation Center, Main Jail, Courts, Background Investigations and Recruitment, CVSA Examiner and represented the Monterey County Sheriff's Office as the Press Information Officer. Commander Pascone was promoted to Commander on March 1, 2003. In that capacity he has been assigned to the Custody Support Services Division, Administrative Division, Court Services Division and Jail Operations; and

WHEREAS, Commander Pascone graduated in June 1984 from Monterey Peninsula College with an Associate of Science Degree in Administration of Justice with certificates in Law Enforcement, Corrections, Security and Paralegal studies; and from the University of Phoenix with a Bachelor of Science in Business Management on June 13, 2004 and a Masters of Science Degree in Leadership from Grand Canyon University in August 2009, both with honors; and

WHEREAS, Commander Pascone graduated from the Federal Bureau of Investigations 236th session of the National Academy at the F.B.I. Academy in Quantico, Virginia, March 2009. He completed the California Commission on Peace Officer Standards Training (P.O.S.T.) Sherman Block Supervisory Leadership Course on June 6, 2001 and, in October 2006 completed the P.O.S.T. Executive Development Course; and

WHEREAS, Commander Pascone has distinguished himself as a leader over his long and illustrious career in both his professional and personal life; dedicating himself to serving others. He was a report writing instructor and peer counselor, Standards in Training and Corrections (STC) Coordinator, authored important projects shaping today's current correctional environment, received numerous commendations and awards from the department and community, and was presented with the U.S. Army Commendation Medal upon his discharge from the military. Commander Pascone was actively involved

in youth sports in the community, Team Captain of the Sheriff's Office Baker to Vegas Running Team and Volunteer Income Tax Assistance (VITA) volunteer; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Monterey on behalf of all citizens thereof, hereby acknowledges, commends and thanks Commander Chris Pascone for his thirty two and a half years of public service to the citizens and residents of Monterey County, as a valued member of the Monterey County Sheriff's Office.

BE IT FURTHER RESOLVED that the Board of Supervisors wishes him and his family success, health and happiness in all their future endeavors and joys in this well-deserved retirement.
