SUMMARY:

The 2018 - 2019 Monterey County Civil Grand Jury Interim Final Report: "Enterprise Resource Planning, Costly Lessons from a Decade-Long Systems Enhancement Effort "was issued on June 24, 2019. By law, the Board of Supervisors and elected County officials are required to respond to specific findings and recommendations as directed therein. Within 90 days of report issuance, on or before September 21, 2019, the Board's response must be filed with the Presiding Judge of the Superior Court, County of Monterey.

The County Administrative Office coordinated preparation of the recommended response to the 2018 - 2019 Monterey County Civil Grand Jury Final Report: "Enterprise Resource Planning, Costly Lessons from a Decade-Long Systems Enhancement Effort" on behalf of the Board of Supervisors. On August 27, 2019, the Board of Supervisors directed staff to return to the Board for final approval. The Board of Supervisors final revised response should be deemed by the Monterey County Civil Grand Jury and the Presiding Judge of the Superior Court, County of Monterey, as the final revised response of the Board of Supervisors to those issues raised by the Grand Jury regarding County operations, except as applicable to elected County officials.
