

**AMENDMENT NO. 2
TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY AND
PIVOT INTERIORS, INC.**

THIS AMENDMENT NO. 2 to AGREEMENT is made by and between the County of Monterey, a political subdivision of the State of California ("COUNTY"), and Pivot Interiors, Inc. ("CONTRACTOR") with respect to the following.

WHEREAS, on December 1, 2020, COUNTY and CONTRACTOR entered into AGREEMENT in the amount of \$90,000 for the term December 1, 2020 through June 30, 2023, for the provision of design, planning, delivery and installation services for new or existing office laboratory furniture or office panel systems on a per project basis; and

WHEREAS, COUNTY and CONTRACTOR entered into AMENDMENT No. 1 adding \$90,000 for a new total AGREEMENT amount of \$180,000 and extending the term for an additional 3 years for a new term of December 1, 2020 to June 30, 2026; and

WHEREAS, COUNTY and CONTRACTOR wish to amend AGREEMENT adding \$150,000 for a new total AGREEMENT amount of \$330,000 and extending the term for an additional 5 years for a new term of December 1, 2020 to June 30, 2031.

NOW THEREFORE, COUNTY and CONTRACTOR hereby agree as follows:

1. **Section 2.0, "PAYMENT PROVISIONS", Section 2.0, shall be amended by removing** "The Total amount payable by the COUNTY to CONTRACTOR under this AGREEMENT is not to exceed the sum of \$180,000" **and replacing it with** "The total amount payable by the COUNTY to CONTRACTOR under this AGREEMENT is not to exceed the sum of \$330,000".
2. **Section 3, "TERM OF AGREEMENT", Section 3.01 shall be amended by removing** "The term of this AGREEMENT is from December 1, 2020 to June 30, 2026, unless sooner terminated pursuant to the terms of this AGREEMENT.", **and replacing it with** "The term of this AGREEMENT is from December 1, 2020 to June 30, 2031, unless sooner terminated pursuant to the terms of this AGREEMENT."
3. Except as provided herein, all remaining terms, conditions, and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT NO. 2 and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of this Amendment No. 2 shall be attached to the original AGREEMENT executed by County on November 2, 2020.
5. This Amendment No. 1 is effective upon July 1, 2026.




