
1. **Definitions.** Capitalized terms used and not defined in this Amendment 7 have the respective meanings assigned to them in the Agreement.

Without limiting the generality of the foregoing, the amendments contained herein will not be construed as an amendment to or waiver of any other provision of the Agreement or as a waiver of or consent to any further or future action on the part of either Party that would require the waiver or consent of the other Party.
