# Discussion

- June 2, 2020 presentation did not include COWCAP increase of \$406,987 from \$1,428,883 to \$1,835,870.
- To accommodate increase, WRA:
  - Reduced Salaries & Benefits by \$45,023
  - Reduced Equipment Purchases by \$170,567
  - Reduced Consultants Cost by \$179,188
  - Usage of Fund Balance of \$12,209
