AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN JACKSON PHYSICIAN SEARCH, LLC AND THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER FOR RECRUITMENT AND PLACEMENT OF PHYSICIAN SERVICES

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on October 1, 2022 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Jackson Physician Search, LLC ("CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

RECITALS

WHEREAS, COUNTY and CONTRACTOR entered into an Agreement for recruitment and placement of physician services with a one (1) year term ending on September 30, 2023 and a total Agreement amount not to exceed \$100,000; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period through September 30, 2024 to allow for services to continue for a full Agreement term of October 1, 2022 through September 30, 2024, with a \$200,000 increase for a total Agreement amount not to exceed \$300,000.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

- 1. The second sentence in Section 2 / Paragraph titled, "PAYMENTS BY COUNTY" shall be amended to the following:
 - "The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$300,000."
- 2. The first sentence of <u>Section 3.1 /Paragraph titled</u>, "TERM OF AGREEMENT", shall be amended to the following:
 - "The term of this Agreement is from October 1, 2022 through September 30, 2024 unless sooner terminated pursuant to the terms of this Agreement."
- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 4. A copy of this Amendment No. 1 shall be attached to the Agreement.
- 5. This Amendment No. 1 shall be effective on October 1, 2023.
