Whereas, Maggie Bennett is a highly regarded community leader who advocates for the most vulnerable populations of Monterey County, was awarded Outstanding Woman of the Year by the State of California Commission on the Status of Women for her work in the areas of reproductive rights, childbirth advocacy, and community service.
