AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN The Camden Group AND THE NATIVIDAD MEDICAL CENTER FOR

Development of Integrated Systems of Healthcare Services

This Amendment No. 2 to Professional Services Agreement ("Agreement"), dated January 1, 2013 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and The Camden Group (Contractor), with respect to the following:

RECITALS

WHEREAS, the County and Contractor amended the Agreement previously on January 1, 2013 via Amendment No. 1; and

WHEREAS, the County and Contractor wish to amend the Agreement to increase the amount of the Agreement by \$1,400,000 and the amount payable for services rendered.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Contractor will continue to provide NMC with the same scope of services as stated in the original Agreement (No. MYA740/A-12386)
- 2. Section 1. "PAYMENTS BY NMC" shall be amended by removing, "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$179,000." and replacing it with "The total amount payable by County to CONTRACTOR under Agreement No. (MYA740/A-12386) shall not exceed the total sum of \$2,200,000 for the full term of the Agreement".
- 3. Section 3 of the Agreement, "TERM OF AGREEMENT" shall be amended by removing, "The term of this Agreement is from January 1, 2013 to June 30, 2013 unless sooner terminated pursuant to this Agreement" and replacing it with "The term of this Agreement is from January 1, 2013 through December 31, 2014 unless sooner terminated pursuant to this Agreement."
- 4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Amendment No. 1 are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Amendment No. 2 and all previous amendments shall be attached to the original Agreement (No. MYA740/A-12386).
- 6. The effective date of this Amendment No. 2 is December 1, 2013.
