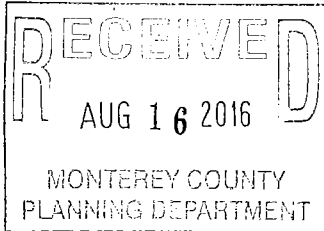

Dear Steve and John:

As you know, the above-referenced permit applications were approved by the Planning Commission on March 11, 2015, and subsequently appealed by the Ecological Rights Foundation (ERF) at a Board of Supervisors hearing on May 7, 2015. The Board of Supervisors continued the appeal hearing for 15 months, and the appeal hearing was scheduled to be heard on August 30, 2016.

In our letter to you dated June 20, 2016, the project applicant, Pick N Pull, and appellant ERF stipulated to and requested that the appeal hearing scheduled for August 30, 2016, be continued to October 1, 2016.

Pick N Pull and ERF have continued to work diligently on the preparation and review of a structural best management practices (BMP) plan.

During the course of their review, ERF has requested from Pick N Pull, and Pick and Pull has granted to ERF, additional time to review the structural BMP plan. In turn, ERF has stipulated to a continuance of the appeal hearing to December 1, 2016.
