## RENEWAL AND AMENDMENT NO. 7 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN The Marblehead Group LLC AND THE NATIVIDAD MEDICAL CENTER FOR

## **Consulting Services**

This Renewal and Amendment No. 7 to Professional Services Agreement ("Agreement"), dated Jun 1, 2008, is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and The Marblehead Group LLC (Contractor), with respect to the following:

## RECITALS

WHEREAS, the County and Contractor amended the Agreement previously on September 1, 2008 via Renewal Amendment No. 1, on July 1, 2009 via Renewal Amendment No. 2, on October 1, 2009 via Renewal Amendment No. 3, on July 1, 2010 via Renewal Amendment No. 4, on July 1, 2011 via Renewal Amendment No. 5, and on July 1, 2012 via Amendment No.6; and

WHEREAS, the County and Contractor wish to amend the Agreement to extend the term end date to allow for existing services to continue; and

WHEREAS, the County and Contractor wish to renew and amend the Agreement to increase the amount of the Agreement by \$100,000 because of the term extension and the amount payable for services rendered.

## **AGREEMENT**

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Contractor will continue to provide NMC with the same scope of services as stated in the original Agreement (No. MYA506).
- 2. Section 2, "PAYMENTS BY NMC" shall be amended by removing, "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$100,000." and replacing it with "The total amount payable by County to CONTRACTOR under Agreement No. (MYA506) shall not exceed the total sum of \$1,530,500 for the full term of the Agreement".
- 3. Section 2, "TERM OF AGREEMENT" shall be amended by removing, "The term of this Agreement is from June 1, 2008 to June 30, 2009 unless sooner terminated pursuant to this Agreement" and replacing it with "The term of this Agreement is June 1, 2008 to June 30, 2014 unless sooner terminated pursuant to this Agreement".
- 4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Amendment Nos. 1, 2, 3, 4, 5, and 6 are unchanged and unaffected by this Renewal and Amendment No. 7 and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Renewal and Amendment No. 7 and all previous amendments shall be attached to the original Agreement (No. MYA506).
- 6. The effective date of this Renewal and Amendment No. 7 is July 1, 2013.
