#### RECOMMENDATION:

It is recommended that the Monterey County Water Resources Agency Board of Directors:

- a. Receive a report on funding sources for the Proposition 1 Implementation Grant Project Protection of Domestic Drinking Water Supplies for the Lower Salinas Valley; and
- b. Recommend that the Monterey County Board of Supervisors transfer \$2,663,300 from the Cannabis Assignment Fund as a contribution toward the Agency's grant matching funds.

#### SUMMARY/DISCUSSION:

On April 20, 2020, the Board of Directors of the Monterey County Water Resources Agency (MCWRA) recommended that the MCWRA Board of Supervisors enter into an agreement with the State Water Resources Control Board (SWRCB) to receive and implement a Proposition 1 Implementation Grant for the destruction of approximately 105 wells (Attachment 2). On May 19, 2020, the MCWRA Board of Supervisors approved the action (Attachment 3).

Financing for the *Protection of Domestic Drinking Water Supplies for the Lower Salinas Valley* project (Project) totals \$9,125,524 with 54% coming from the State Water Resources Control Board), and 46% coming as MCWRA match that is met through a combination of MCWRA in-kind services totaling \$1,534,495 and additional funds totaling \$2,663,300 over a three-year period.

The additional \$2.66 million in funds will be needed over three fiscal years, with \$399,499 in FY 2020-21, \$1,509,201 in FY 2021-22, and \$754,600 in FY 2022-23 as shown in Tables 1 and 2.

At the April 20, 2020 and May 19, 2020 meetings, MCWRA staff identified Fund Balance in Funds 131, 132, and 134 as a possible funding source for the additional \$2.66 million; however, utilization of these reserves to fund this project will require a reprioritization of other projects currently identified for funding from this source in the next three fiscal years. These projects include routine maintenance at the tertiary treatment plant and on the CSIP Distribution system; cathodic protection; water scheduling improvements to assist with reducing delivery shortages; electrical upgrades; and, improvements to keep facilities operable during routine maintenance activities further reducing full shutdowns.

In an effort to offset the impact to these reserves and the projects identified above, MCWRA staff recommends a request to the County for a contribution from the Cannabis Assignment Fund toward this project in the amount of \$2,663,300. This request is in addition to a \$1,000,000 loan pledged by the County to the Agency from the Cannabis Assignment Fund for the Pajaro River Flood Risk Management Project.

On September 3, 2020, the MCWRA Finance Committee supported a request to Monterey County for a transfer of \$2,663,300 from the Cannabis Assignment Fund as a contribution toward MCWRA's grant match for this project.

MCWRA is also exploring other outside funding sources, such as contributions from well owners or water purveyors that will benefit from the project. If these efforts are successful, they will offset or potentially eliminate the request.

### SUMMARY/DISCUSSION:

On April 20, 2020, the Board of Directors of the Monterey County Water Resources Agency (MCWRA) recommended that the MCWRA Board of Supervisors enter into an agreement with the State Water Resources Control Board (SWRCB) to receive and implement a Proposition 1 Implementation Grant for the destruction of approximately 105 wells (Attachment 2). On May 19, 2020, the MCWRA Board of Supervisors approved the action (Attachment 3).

Financing for the *Protection of Domestic Drinking Water Supplies for the Lower Salinas Valley* project (Project) totals \$9,125,524 with 54% coming from the State Water Resources Control Board), and 46% coming as MCWRA match that is met through a combination of MCWRA in-kind services totaling \$1,534,495 and additional funds totaling \$2,663,300 over a three-year period.

The additional \$2.66 million in funds will be needed over three fiscal years, with \$399,499 in FY 2020-21, \$1,509,201 in FY 2021-22, and \$754,600 in FY 2022-23 as shown in Tables 1 and 2.

At the April 20, 2020 and May 19, 2020 meetings, MCWRA staff identified Fund Balance in Funds 131, 132, and 134 as a possible funding source for the additional \$2.66 million; however, utilization of these reserves to fund this project will require a reprioritization of other projects currently identified for funding from this source in the next three fiscal years. These projects include routine maintenance at the tertiary treatment plant and on the CSIP Distribution system; cathodic protection; water scheduling improvements to assist with reducing delivery shortages; electrical upgrades; and, improvements to keep facilities operable during routine maintenance activities further reducing full shutdowns.

In an effort to offset the impact to these reserves and the projects identified above, MCWRA staff recommends a request to the County for a contribution from the Cannabis Assignment Fund toward this project in the amount of \$2,663,300. This request is in addition to a \$1,000,000 loan pledged by the County to the Agency from the Cannabis Assignment Fund for the Pajaro River Flood Risk Management Project.

On September 3, 2020, the MCWRA Finance Committee supported a request to Monterey County for a transfer of \$2,663,300 from the Cannabis Assignment Fund as a contribution toward MCWRA's grant match for this project.

MCWRA is also exploring other outside funding sources, such as contributions from well owners or water purveyors that will benefit from the project. If these efforts are successful, they will offset or potentially eliminate the request.

**County Counsel Summary**

*This ordinance amends Ordinance No. 04065 (adopted May 30, 2000) to remove the boat dock license fees and penalties from the Ordinance and to instead reference the Monterey County Water Resources Fee Article within the Monterey County Fee Resolution to set the fee amounts. Moving the fee amounts from the Ordinance to the Fee Article will enable the Monterey County Water Resources Agency to more easily update the fees.*

The Board of Supervisors of the Monterey County Water Resources Agency hereby ordains as follows:

SECTION 1. Section 5 of Ordinance No. 04065 is hereby amended to read as follows:

License and other fees charged under the provisions of this Ordinance and fines, penalties and enforcement costs associated with violations of this Ordinance not otherwise set forth herein, shall be established by the Agency Board of Supervisors and as set forth in the Monterey County Fee Resolution, pursuant to Chapter 1.40 of the Monterey County Code, as amended from time to time.

SECTION 2. Section 16 of Ordinance No. 04065 is hereby amended to read as follows:

(a) It shall be unlawful for any person to violate any provision, or to fail to comply with any of the requirements, of this Ordinance. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of this Ordinance shall be guilty of a misdemeanor. No proof of knowledge, intent, or other mental state is required to establish a violation.

(b) Any violation which occurs or continues to occur from one day to the next shall be deemed a separate violation for each day during which such violation occurs or continues to occur.

(c) If licensee fails to comply with the standards and requirements in this ordinance, the property owner shall assume full responsibility for all fees owed to the Agency, including any and all disposal fees and removal expenses as appropriate.

(d) Agency shall have the right to remove, at the property owner's and/or licensee's expense, all licensed or unlicensed, tethered or untethered, boat docks and log-booms not complying with the licensing conditions set forth herein.

SECTION 3. SEVERABILITY

If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

SECTION 4. EFFECTIVE DATE

This ordinance shall become effective on the thirty-first day following its adoption.

The Board of Supervisors of the Monterey County Water Resources Agency hereby ordains as follows:

SECTION 1. Section 5 of Ordinance No. 04065 is hereby amended to read as follows:

~~License and other fees charged under the provisions of this Ordinance and fines, penalties and enforcement costs associated with violations of this Ordinance not otherwise set forth herein, shall be established by the Agency Board of Supervisors and as set forth in the Monterey County Fee Resolution, pursuant to Chapter 1.40 of the Monterey County Code, as amended from time to time. Prior to issuance of an initial or renewal license, the licensee shall pay to the Agency an annual fee of \$60.00 per dock for all single slip docks, or \$60.00 for the first slip plus \$20.00 for each additional slip for all multiple docks. The General Manager shall determine the number of slips for which any particular dock is designed.~~

SECTION 2. Section 16 of Ordinance No. 04065 is hereby amended to read as follows:

(a) ~~It shall be unlawful for any person to violate any provision, or to fail to comply with any of the requirements, of this Ordinance. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of this Ordinance shall be guilty of a misdemeanor. No proof of knowledge, intent, or other mental state is required to establish a violation. (b) Any violation which occurs or continues to occur from one day to the next shall be deemed a separate violation for each day during which such violation occurs or continues to occur.

(c) If licensee fails to comply with the standards and requirements in this ordinance, the property owner shall assume full responsibility for all fees owed to the Agency, including any and all disposal fees and removal expenses as appropriate.

(d) Agency shall have the right to remove, at the property owner's and/or licensee's expense, all licensed or unlicensed, tethered or untethered, boat docks and log-booms not complying with the licensing conditions set forth herein.

SECTION 3. SEVERABILITY

If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

SECTION 4. EFFECTIVE DATE

This ordinance shall become effective on the thirty-first day following its adoption.

## Reservoir Release Update

### SUMMARY/DISCUSSION:

The Board of Directors receives monthly updates on the status of Agency reservoirs.

**RESERVOIR ELEVATION / STORAGE:** As of September 9, 2020, San Antonio Reservoir has a water surface elevation of approximately 696.9 feet (NGVD 29), with 58,895 acre-feet of storage. Nacimiento Reservoir has a water surface elevation of approximately 735.4 feet, with 106,350 acre-feet of storage. San Antonio Reservoir is currently at 18% of storage capacity and Nacimiento Reservoir is at 28% of capacity.

**RESERVOIR RELEASES:** The Agency continues to make conservation releases from both reservoirs to recharge the Salinas Valley Groundwater Basin and provide flows in support of the Salinas River Diversion Facility (SRDF) with required steelhead passage flows to the Salinas River Lagoon. Current release rates of 640 cfs (355 cfs from Nacimiento Reservoir and 285 cfs from San Antonio Reservoir) are meeting these needs in addition to required minimum fisheries release requirements.

The Salinas River Lagoon has been closed since May 17<sup>th</sup> after having opened to the ocean on April 7<sup>th</sup>.

Minor deviations in release rates are not presented in this report but are documented in the Salinas Valley Water Project Annual Flow Reports.

Releases as of September 9, 2020:

- Nacimiento Reservoir: 355 cfs
- San Antonio Reservoir: 285 cfs

Total releases from both reservoirs to the Salinas River are approximately 640 cfs. The following “provisional” flows have been recorded by the USGS:

- Salinas River near Bradley: 631 cfs
- Salinas River at Soledad: 264 cfs
- Salinas River near Chualar: 119 cfs
- Salinas River near Spreckels: 40 cfs

## Well Permit Application Activities Update

### SUMMARY/DISCUSSION:

In support of Monterey County's Well Permit Application Program the Agency acts as technical advisor to the program's lead agency, the Environmental Health Bureau (EHB). In accordance with a 1991 interdepartmental Memorandum of Agreement between the Agency and EHB, the Agency performs a comprehensive review process on well permit applications for new wells pumping five acre-feet of water or more per year, as well as for proposed well destructions and repairs.

The Agency provides review and/or advisement to EHB within five (5) business days of receiving new well permit applications. The Agency also reviews final well designs and annular seal depth proposals on an on-going basis and is committed to providing a response to EHB within twenty-four (24) hours of receiving design proposals.

The Agency receives funds that cover staff time for well application review, well completion report processing, and database maintenance from fees collected by EHB. The Agency's fees are defined in Article XI of the Monterey County Fee Resolution.

Table 1 (attached) provides a summation of well permit applications received in the last month for evaluation by Agency staff, categorized by permit type, Agency management area, and aquifer unit. Also included is a tabulation of new well applications reviewed for the fiscal year. This table is provided to the Board of Directors and Basin Management Advisory Committee on a monthly basis.

Publication of the Agency's Report, "Recommendations To Address the Expansion of Seawater Intrusion in the Salinas Valley Groundwater Basin (October, 2017) and subsequent adoption of Interim Urgency Ordinance 5302 and Ordinance 5303 by the Monterey County Board of Supervisors (May 22, 2018 and June 26, 2018, respectively) have led to increased interest in data related to wells in and extractions from the Deep Aquifers (Figure 1).

Figure 2 depicts the history of well installation in the Deep Aquifers by water use category. As illustrated in the chart, a total of fifty-six (56) wells have been installed in the Deep Aquifers since 1974, with twenty-three (23) of those wells being constructed in the last ten years, including fifteen (15) within the last three years. Figure 2 includes a tabular historical summary of reported annual Deep Aquifer well extractions by water use category.

Four (4) additional permits have been issued for new Deep Aquifers wells but construction has not been completed as of the date of this report. One proposed well was applied for as a "replacement well" under provisions of interim Ordinance No. 5302, which expired on May 21, 2020. The remaining three (3) proposed wells were applied for as replacement wells after the expiration of Ordinance No. 5302.



Salinas Valley Basin Groundwater Sustainability Agency's Seawater Intrusion Group (SVBGSA-SWIG) and the County of Monterey CAO's Deep Aquifers Wells Working Group (DAWWG) Activities Update.

### SUMMARY DISCUSSION:

#### Seawater Intrusion Group (SWIG)

The formation of a seawater intrusion group was identified in section 9.3.7 of the SVBGSA's 180/400 Foot Aquifer Subbasin Groundwater Sustainability Plan. Priority Management Action 6 of that plan states that the "*SVBGSA will develop and coordinate a working group to address the issues associated with seawater intrusion.*" The goal of the SWIG will be to develop a comprehensive set of projects and management actions that control seawater intrusion while providing cost effective water supplies for the region. At the SVBGSA's May 14, 2020 Board of Directors meeting, Gary Petersen, Senior Advisor to the SVBGSA presented an overview of SWIG organization and mission (Attachment 1).

A preliminary goal of the SVBGSA-SWIG will be to develop consensus on the science of seawater intrusion in the Salinas Valley Groundwater Basin. In order to achieve this goal, the SVBGSA-SWIG has formed a Technical Advisory Committee (TAC) whose charge is to help develop and formulate the understanding of that science. Each agency or stakeholder organization member of the SWIG can propose a SWIG representative. The SWIG representative must be a qualified individual with expertise in hydrology, hydrogeology or other relevant science. The TAC met for the first time on August 31, 2020. From that meeting, it was decided that the TAC will work to, among other things, develop the framework for a study of the Deep Aquifers in the coastal region.

#### Deep Aquifers Wells Working Group (DAWWG)

At the Monterey County Board of Supervisors meeting on May 19, 2020; in response to the Agency's presentation of the report "*Recommendations to Address the Expansion of Seawater Intrusion in the Salinas Valley Groundwater Basin: 2020 Update*", the Supervisors directed the County CAO to form a working advisory group to make recommendations to the CAO regarding the placement of new wells in the 180/400 Foot Aquifer subbasin of the Salinas Valley Groundwater Basin.

That group, the Deep Aquifers Wells Working Group (DAWWG), has met on a roughly weekly basis to deliberate on and develop consensus on recommendations. The DAWWG consists of County, Agency and SVBGSA staff, along with representatives from the Farm Bureau and the Growers Shippers Association. Results of those deliberations will be presented in two public forums to provide an opportunity for public deliberations and input prior to the CAO recommendations to the Supervisors

Additionally, the DAWWG has deliberated on the impacts of a recent California Supreme Court decision as to whether well construction permits are subject to California Environmental Quality Act (CEQA) review. As a result of the courts finding, the Board of Supervisors will be asked to adopt an urgency ordinance to suspend the processing of water well construction permit applications for a period of 90 days so the impact on the County's well ordinance can be studied. In order to help in understanding the impact of these actions, County staff developed a Frequently Asked Questions document on the California Supreme Court action (Attachment 2).





## California Supreme Court Clarifies Whether Well Construction Permits Are Subject to CEQA

On August 27, 2020, the California Supreme Court in the *Protecting Our Water and Environmental Resources v. County of Stanislaus* (“*Protecting Our Water*”) case held that Stanislaus County could not categorically classify its issuance of groundwater well construction permits as ministerial decisions exempt from environmental review under the California Environmental Quality Act (“CEQA”). Because many counties administer their well programs utilizing similar ministerial classifications, the *Protecting Our Water* case has significant practical considerations statewide, including in Monterey County.

Here are frequently asked questions concerning the *Protecting Our Water* case and its impact in Monterey County:

### Frequently Asked Questions

**Q:** What is the issue facing Monterey County?

**A:** The issue is whether some level of environmental review is necessary for County issuance of water well construction permits in light of the recent Supreme Court decision. The Monterey County Board of Supervisors will be considering an urgency ordinance to enact a 90-day suspension of the processing of any well construction permit applications in order to ensure that the precedential ruling in the *Protecting Our Water* case is fully understood, and any necessary or appropriate amendments to the County’s water well construction permit ordinance are considered. This 90-day suspension is not intended to be permanent suspension on the processing of water well construction permits; it is expected that the suspension period will provide time to make recommendations to the Board of Supervisors regarding amendments to County regulations for processing new water well construction permit applications.

**Q:** What is the difference between a ministerial and discretionary decision on a well construction permit?

**A:** Under CEQA, ministerial approvals are those that involve little or no discretion, merely apply a checklist to the facts as presented, and are often issued over-the-counter by county staff. In contrast, discretionary approvals are those that involve judgment or deliberation, and allow a county to use discretion to decide whether to issue the approvals and how best to shape or condition those approvals to avoid or mitigate environmental impacts. CEQA environmental review applies only to discretionary approvals, not ministerial approvals.

**Q:** Does the *Protecting Our Water* decision hold that all well construction permits are discretionary?

**A:** No. The California Supreme Court held that there was not a bright-line answer to this question. Instead, whether a well construction permit is discretionary must be determined based on the specific language of the ordinance governing the permit's issuance and the circumstances of the particular application. In other words, whether the jurisdiction's well construction ordinance allows for the decision maker to exercise judgment regarding a particular well permit application will determine whether the permit's issuance is discretionary and subject to CEQA review.

**Q:** What was found to be discretionary in Stanislaus County's well construction ordinance?

**A:** The ordinance governing Stanislaus County's issuance of the permits incorporated certain state standards. Among other requirements, the standards authorized Stanislaus County to exercise judgment when it decides to approve or disapprove a permit. The California Supreme Court held that because this language gave Stanislaus County discretion to identify environmental issues and to condition the well's construction to avoid those issues, the County's issuance of well permits was, at least in some circumstances, discretionary. As such, the Court found that Stanislaus County violated CEQA by categorically classifying the issuance of all well construction permits as ministerial.

**Q:** How does the *Protecting Our Water* decision impact my ability to obtain a well construction permit from Monterey County?

**A:** Chapter 15.08 of the Monterey County Code sets forth the application and decision-making process for the County in considering applications for well construction permits. The Chapter sets forth certain technical requirements that appear to be purely ministerial in their application; however, the Chapter also gives the Health Officer discretion to impose unspecified conditions on a permit, grant variances, and deny an application if in his/her judgment it would defeat the purposes of the Chapter. By way of example only, the Health Officer might determine that a new well would have an impact on a nearby well or wells, and impose spacing or other conditions on a well permit to avoid that impact. Such authority could be considered sufficiently discretionary to make the approval of well construction permits subject to environmental review.

**Q:** Will Monterey County now require CEQA environmental review on all well construction permits?

**A:** The Board of Supervisors will be asked to adopt an urgency ordinance to suspend the processing of water well construction permit applications for a period of 90 days so the impact on the County's well ordinance can be studied. In the absence of a suspension, based on the current language of Chapter 15.08, it is likely that well construction permits would

be subject to environmental review. CEQA review would likely entail preparation of an initial study, and the results of the initial study would determine whether further environmental review was necessary.

**Q:** Will Monterey County amend Monterey County Code Chapter 15.08 given the *Protecting Our Water* decision?

**A:** The 90-day suspension of processing applications will allow the County staff to review and determine how the case applies to Chapter 15.08, and make recommendations to the Monterey County Board of Supervisors. Revisions to Chapter 15.08 would require Board adoption of an ordinance to amend the County Code.

**Q:** On May 19, 2020, the Monterey County Board of Supervisors directed the County Administrative Officer to create a Deep Aquifer Well Working Group to work with stakeholders to provide recommendations to the Board concerning well construction permits and funding a study of the Deep Aquifers. How does the *Protecting Our Water* decision impact that group's work?

**A:** The Deep Aquifer Well Working Group continues to work on a recommendation and will also now evaluate the new additional issues raised by the *Protecting Our Water* decision. The Group plans to move forward soon with stakeholder meetings and to report back to the Board of Supervisors by the end of October 2020.
