Adopt a resolution to:

- a. Authorize the Sheriff's Office to accept Vehicle Registration Fees Under AB 767 (Section 9250.14 of the California Vehicle Code) to Deter, Investigate and Prosecute Vehicle Theft Crimes
- b. Request the State of California Department of Motor Vehicles (DMV) increase the one dollar (\$1) vehicle registration fee authorized pursuant to California Vehicle Code Section 9250.14 to two dollars (\$2); funding will be used by the Sheriff's Office to support local programs targeting vehicle theft crimes:
- c. Request the DMV to increase from two dollars (\$2) to four dollars (\$4) the registration fee for commercial vehicles pursuant to California Vehicle Code Section 9250.14(a)(3)
- d. Commence collection of the fee of two dollar (\$2) or four dollar (\$4) for commercial vehicles on vehicle registrations within the County of Monterey, effective July 1, 2025.

WHEREAS, California Vehicle Code Section 9250.14 previously authorized that upon the adoption of a resolution by any county board of supervisors, a fee of one dollar (\$1.00) shall be paid at the time of registration or renewal of registration of every vehicle registered to an address within that county, except those expressly exempt from payment of registration fees, and a fee of two dollars (\$2.00) shall be paid at the time of registration or renewal of registration of every commercial motor vehicle registered to an address within that county, except those expressly exempt from payment of registration fees; and

WHEREAS, on May 25<sup>th</sup>, 1993, the Monterey County Board of Supervisors adopted such a resolution authorizing the collection of fees pursuant to Vehicle Code Section 9250.14 of the California Vehicle Code: and

**WHEREAS**, effective January 1<sup>st</sup>, 2014, AB 767 (Levine) revised Section 9250.14 of the California Vehicle Code to authorize that upon adoption of a resolution by any county board of

supervisors, that the previous one dollar (\$1.00) fee shall be increased to a total fee of two dollars (\$2.00), and that the previous two dollar (\$2.00) commercial vehicle fee shall be increased to a total fee of four dollars (\$4.00), and that those fees shall be paid at the time of registration or renewal of registration of every vehicle registered to an address within that county, except those expressly exempt from payment of registration fees; and

WHEREAS, funds allocated to a county under Section 9250.14 of the California Vehicle Code shall be expended to fund programs which enhance the capacity of local law enforcement and prosecutors to deter, investigate and prosecute vehicle theft crimes; and

WHEREAS, funds previously allocated to Monterey County under Section 9250.14 of the California Vehicle Code have not risen since May 25, 1993, and have failed to keep pace with the rising cost to local law enforcement and prosecutors for deterring, investigating, and prosecuting vehicle theft crimes.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Monterey does hereby find and determine that a fee of two dollars (\$2.00) shall be paid at the time of registration or renewal of registration of every vehicle registered to an address within the County of Monterey, except those expressly exempt from payment of registrations fees, and a fee of four dollars (\$4.00) shall be paid at the time of registration or renewal of registration of every commercial vehicle registered to an address within the County of Monterey, except those expressly exempt from payment of registration fees.

**BE IT FURTHER RESOLVED** that any money allocated to the County of Monterey pursuant to Section 9250.14 of the California Vehicle Code shall be expended to fund programs which enhance the capacity of local law enforcement and prosecutors to deter, investigate, and prosecute vehicle theft crimes.

**NOW, THEREFORE**, the County of Monterey Board of Supervisors is hereby resolved to approve the following:

Adopt a resolution to:

- a. Authorize the Sheriff's Office to accept Vehicle Registration Fees Under AB 767 (Section 9250.14 of the California Vehicle Code) to Deter, Investigate and Prosecute Vehicle Theft Crimes.
- b. Request the State of California Department of Motor Vehicles (DMV) increase the one dollar (\$1) vehicle registration fee authorized pursuant to California Vehicle Code Section 9250.14 to two dollars (\$2); funding will be used by the Sheriff's Office to support local programs targeting vehicle theft crimes:

- c. Request the DMV to increase from two dollars (\$2) to four dollars (\$4) the registration fee for commercial vehicles pursuant to California Vehicle Code Section 9250.14(a)(3)
- d. Commence collection of the fee of two dollar (\$2) or four dollar (\$4) for commercial vehicles on vehicle registrations within the County of Monterey, effective July 1, 2025.
