WHEREAS, on February 11, 1963, the Board of Supervisors adopted Ordinance No. 1278 thereby granting a Franchise Agreement to California Water & Telephone Company, a corporation (Franchisee), for the period of 50 years, the right to install and thereafter maintain, replace, and use underground water pipelines and appurtenances for the distribution of water to the public for any and all purposes in so many and in such parts of the public highways, roads, streets, and ways within the unincorporated territory of the County of Monterey, other than in locations where the grantee has prior right by grant, as the grantee from time to time elect to use as described in and contained in Ordinance No. 1278; and

WHEREAS, on November 19, 2012, California American Water Company formerly known as California Water & Telephone Company, a corporation, (Franchisee) requested to extend or renew their existing Franchise Agreement (Ordinance No. 1278); and

WHEREAS, the County requested an extension of twelve (12) months to provide sufficient review time and Franchisee has agreed; and

WHEREAS, County desires to extend the term date of the Franchise Agreement with California American Water Company formerly known as California Water & Telephone Company, a corporation, pursuant to Ordinance No. 1278 subject to the same terms and conditions, for the period of twelve (12) months, which is specified to be from February 11, 2013 through February 10, 2014.
